Please find below the following information explaining the reasons why the above call points are not required to be CE marked for the above Directives.

## EMC Directive 89/336/EEC

It has been determined by the Trading Standards Authorities in the United Kingdom that these call points are excluded from the Regulations and therefore it is unnecessary to affix the CE mark. Indeed, as is clearly specified in the Regulations, we are precluded from undertaking such marking. These call points contain a very simple circuit, the components of which cannot emit and are not susceptible to either RFI or ESD and therefore can be classed as benign items.

Low Voltage Directive 73/23/EEC

The above models have been designed for use on systems not exceeding 50 VAC or 75 VDC and are therefore excluded from the Regulations.
